

National Security Law Seminar

June 9-13, 2025



Columbia Law School invites applications to its National Security Law Seminar, a one-week program taught on the iconic Columbia University campus in the City of New York.

The program offers a comparative understanding of U.S. legal institutions, policies, and practices related to the national security field. It is designed for professionals trained outside the United States, including lawyers, policy makers, military personnel, police officers, cybersecurity experts and others.

The National Security Law Seminar offers 16 hours of non-credit classroom instruction presented by Prof. Bobby Chesney, Dean of the University of Texas School of Law, with participation by others including staff from the United States Military Academy at West Point.

Academic Program

Monday, June 9: Organization and Processes of U.S. National Security

Key U.S. government agencies, their legal sources of authority, and the legal tools they employ.

Tuesday, June 10: Surveillance and Cybersecurity Law

Issues arising under both U.S. law and international law.

Wednesday, June 11: Use of Military Force – Session I

Issues arising under international law, including international humanitarian law.

Thursday, June 12: Use of Military Force – Session II

Current and possible future issues, including counterterrorism, arising under domestic U.S. law.

Friday, June 13: Reception

Closing reception hosted by [Columbia Law School's National Security Law Program](#).

Key Points

Dates: June 9-13, 2025. Group and individual applications now accepted on a rolling basis.

Structure: 16 hours of classroom instruction, with a Keynote and Closing Reception hosted by [Columbia Law School's National Security Law Program](#).

Fees: The program fee is \$2,500 with on-campus housing, and \$2,000 without housing. Affiliates of Columbia Law School partner institutions qualify for special discounts.
