HOW TO STUDY ABROAD



RESEARCH

Review your remaining UCLA degree requirements (GE, pre-major, major, minor, foreign language, & upper division units).



IDENTIFY

Find UCEAP courses and identify options that are comparable to your degree requirements. They do not have to be an exact match.



DISCUSS

If you have questions, meet the advisors at the International Education Office to review program details and locate syllabi.



PETITION

Petition with your Economic advisor to apply study abroad coursework toward your degree requirements.

- * Pre-approvals are provided by the Economics department. You *can* petition for credit before your program starts to determine whether you may receive major credit.
- * Students may apply up to three pre-approved Economics courses towards the Economics major, but of the three, a maximum of one course may be a "Regional" Economics course.
- * All UCEAP courses count toward upper division units; therefore, even if your department denies your petition, you will still make progress toward your degree.

MAJOR SPECIFIC INFORMATION

Lower Division Major Prep	No. The following courses cannot be taken abroad: Econ 11, Econ 41, Econ 101, Econ 102, Econ 103/103L, Econ 104/104L.
Major Electives	Yes. Major electives can be fulfilled abroad; however, no management or business-related courses will be considered; <i>only</i> Economics courses.
List of Pre-Approved Coursework?	Yes. While there is not a list of pre-approved courses posted online, students may meet with an Economics advisor to inquire about pre-approved courses. Courses approved in a regular term (FWS) are approved for 6 quarters. Courses taken during the summer are approved only for that summer and must be petitioned again each summer.
